ENTRY BLANK

RULES AND REGULATIONS - READ CAREFULLY

- A. EACH DRIVER MUST FILL OUT AN ENTRY BLANK. *Entries limited to area and adjoining county residents only.*
- B. ALL RULES AND REGULATIONS MUST BE OBSERVED. Track operators or promoters reserve the right to approve or reject any and all entries.
- C. ONLY OWNERS, DRIVERS OR MECHANICS, will be permitted in the pit area or on the track.
ENTRY FEE: This covers driver only. \$20.00 (NO REFUNDS). The entry fee must be cash or money order. NO PERSONAL CHECKS.
- D. NO CARS permitted on the track before the heat they are to participate in.
- E. NO ALCOHOLIC BEVERAGES allowed in the pit area; drivers that are drinking will be disqualified.
- F. **NO PASSENGERS IN OR ON THE CAR AT ANY TIME EXCEPT THE DRIVER.**
- G. MUST BE STREET LEGAL - Registered, Inspected and Valid Insurance Card.
- H. AT YOUR OWN RISK! - Fair provides no insurance for injury or damage to vehicle.

DRIVERS ENTRY

- 1. DRIVERS MUST BE 18 YEAR OF AGE.
- 2. ALL DRIVERS MUST SUPPLY THEIR OWN CARS. Entries limited to 2 cars per driver.
- 3. **REGISTRATION AT 5 p.m.**
- 4. ALL DRIVERS must enter & check in their own car.
- 5. ANY DRIVERS NOT OBEYING THE RULES WILL BE DISQUALIFIED.

PARTICIPATING REGULATIONS

- 1. SAFETY BELTS AND HELMETS are required. Put a rope or chain behind drivers seat to keep it from tipping back.
- 2. ADDITIONAL SAFETY REGULATIONS MAY BE IMPOSED depending on the track.
- 3. Rules are subject to change to fit the event. **THE DECISION OF JUDGE IS FINAL.**
